15 companies supported the Skillsfuture Earn and Learn Programme (ELP) and finally, the day came which showcased the fruition of the hard support – to witness the graduation of 35 participants in the Logistics ELP.

The ELP Completion Ceremony for Logistics was held on 4 January 2017 (Wednesday) at The Republic Polytechnic Cultural Centre (TRCC) Studio. The Logistics ELP allows companies to gauge the potential of young talents and make longer-term plans for succession planning and talent development while, on the other hand, the participants will gain exposure and expertise in the relevant sectors through on-the-job training, in combination with their classroom lessons. This is a great head start to improve the quality of talents in the logistics industry.

Government Events / News – NTP

Bringing the National Trade Platform to life

In building the National Trade Platform (NTP), the project team continued to collaborate with representatives from industries, developers, as well as government agencies to co-design the NTP.

NTP website user experience

More than 20 sessions were held in November 2016 with developers, current TradeNet and TradeXchange users, business development executives, and business owners.

The participants were invited to preview the wireframes – consisting of images that display the functional elements of the NTP website – and asked to complete a series of tasks, such as activating an account, submitting a TradeFIRST assessment, and viewing a company profile.

The feedback from these sessions will be incorporated in the new NTP design for enhanced user experience.

Ensuring Business Continuity

To ensure business continuity when the NTP is launched, the team has engaged the TradeNet frontend solution providers, TradeXchange value-added service providers, and various competent authorities early.

Besides validating their needs with the new NTP functionalities, the team is also working closely with them to ensure the smooth transition of the existing Business-to-Government permit-related services, and adding Business-to-Business value-added services to the new platform.

Focus Group Discussions & Innovation Workshops

Over 50 participants from multinational companies, small and medium-sized enterprises, and trade finance organisations took part in the multiple focus group discussions and workshops. The participants shared their business challenges and suggested how the NTP can help to improve their operational efficiency.



Focus group discussions were also held with representatives from the trade and logistics sectors to gather feedback on the design of the key platform capabilities for the NTP.

Building the NTP Developer Community

The NTP Team had engaged developers, both professionals and representatives from institutes of higher learning, to co-design the open innovation platform. Valuable insights were provided on industry practices that will help nurture a vibrant developer community on the NTP.

Workplace Resilience

"It is no longer a question of whether an attack will take place, but really, when is an attack going to take place in Singapore and we have to be prepared for that."

With the rising terrorism threats globally, businesses, being the key driver of Singapore's economy, need to be prepared and resilient in face of any workplace crises, including terror attacks. Hence, the workplace domain needs to stand united in our efforts to safeguard our lives and our workplaces against terrorism. There is a part for everyone in preventing terrorism and handling terrorism when it happens.



Be VIGILANT

Be *attentive* to activities and behaviour within your workplace that may be indicators of radicalization, e.g. people who

- Express the belief that violence is justified and who idolise, or sympathise with terrorists and their causes
- Try to influence others to support terrorism and/or participate in terrorist activities
- Display insignia or symbols in support of terrorist groups

Be *alert* to tell-tale indicators of suspicious or intent.

- Anyone who acts to hide his identity, purpose of visit, or objects on his body
- Anyone loitering for an extended period of time
- Any item left unattended in public areas, or abandoned in ways that seem out of place

Be *involved* as 'eyes and ears' on the ground and report any suspicious behaviours.

Do not approach the suspicious persons or touch the suspicious items. Inform the security officer or call the Police (999/ SMS 71999) for urgent assistance.

Be COHESIVE

Acts of terror threaten to weaken our society's social fabric. Fostering an inclusive work environment and cohesive workforce during peacetime will help us weather crises.

- Be involved by organizing and participating in activities that promote intercultural exchange and bonding
- Inculcate values like respect, harmony and cooperation, e.g. by making them part of your organization's mission, vision or corporate values
- Ensure fair, consistent and transparent employment practices

Be RESILIENT

Organisations:

Safeguard your organisation's assets by ensuring your crisis response and business continuity plans take into account key areas such as People, Processes, Physical Assets and Information. Selected employees can also be trained on relevant skills to address the psychological, emotional and social impact of terrorism.

Individuals:






PROFITABILITY RATIO, 2005 & 2015






Air Transport Perspective 2015





SAAA held the 43rd Annual General Meeting (AGM) at the Tanah Merah Country Club (Garden course) on 5 January 2017.

It was themed 'Operational & Human Resource Excellence Booster 2017'.

Mr Steven Lee, Chairman of SAAA@Singapore, delivered the welcome address and highlighted on the importance of the ability to change and adapt, alongside the World affairs and be in control of our company's developments.

Mr Samuel Seah provided an overview of Personal Data Protection Commission.

Organizations have a protection obligation for their personal data (PD) and it becomes essential that security arrangements are made to prevent unauthorized access.

For a start, organizations can take stock of their personal data inventory, proceed to appoint a Data Protection Officer (DPO) and implement data protection policies.

LTC Ang Ai Hua spoke of her role in employers engagement and shared on the MINDEF CTRC - a Career Transition Resource Centre that provides value-added services to transiting servicemen and employers who are keen to tap on the pool of talents.

She encouraged organizations to attain the NS Mark – a national level accreditation scheme that recognizes business with policies and human resource practices that support National Service (NS) and Total Defence (TD).

Dr Nomura and Mr Luthra presented on 'Managing travel-related risks faced by your employees'.

They highlighted on the importance of a proactive risk mitigation – which will result in lower costs and disruptions with a risk management model set in place.

Prior to travel aboard, an appropriate health risk assessment could have also prevented at least 36% of health events occurring to travelers.

Case Study - Collision between Prime Mover and Motorcycle

Description of Incident

A prime mover was waiting to make a right turn at a traffic junction. Unaware to the driver, a motorcycle had come alongside on the left of the prime mover and stopped in front of it. As the prime mover moved forward and made its turn, it hit the motorcycle, throwing the motorcyclist and his pillion off their seats. The motorcyclist was then run over and killed by the prime mover's wheel, while the pillion escaped with some abrasion injuries.

Findings

At the passenger side of the prime mover, the windscreen was pasted with road tax discs and the dashboard was piled with documents. These items obstructed the driver's sight, denying him a clear view of what was in front of the prime mover. The driver's view was further hampered by his physical height which was below 1.6 metres.

Causal Analysis

- Evaluation of loss One motorcyclist killed.
- Type of contact Front-to-rear vehicle collision.
- Immediate cause Failure to notice motorcycle.
- Basic cause Driver's view was obstructed by documents placed on the dashboard and road tax discs pasted on the windscreen.

Recommendations

- Ensure that the driver has a clear view of his surroundings from the cabin
- Adjust the rear and wing mirrors for better visibility of the vehicle's surrounding
- Install in-vehicle camera units to minimise the number of blind spots

Changi's T₅ likely to be served by 2 MRT Lines

It was first revealed by Transport Minister Khaw Boon Wan in July at an MRT groundbreaking ceremony that there was a possibility to extend the new lines to Changi Airport.

Now, the plans is for future Thomson-East Coast and Cross Island lines to be linked to the new mage terminal, Terminal 5. Thomson-East Coast Line is scheduled to open in stages from 2019 to 2024 whereas Cross Island Line is targeted to be completed by 2030. This is to improve accessibility to travelers and visitors.

Building a station at Changi East's future industrial zone would be a boon for airport workers too, said Singapore Aircargo Agents Association Chairman, Mr Steven Lee.

New Speed Camera deployed at Tanah Merah Coast Road

The Average Speed Camera (ASC), a new speed camera system, will be introduced along the 5km Tanah Merah Coast Road next year. This is to heighten awareness and consciousness of speeding and curb dangerous driving behaviors.

The ASC tracks the vehicle on radar when it enters monitoring zone and computes average speed of a vehicle by calculating distance travelled against time. The technology used in the ASC can distinguish violations by normal vehicles from heavy vehicles.

Motorists will need to be more careful and vigilant in keeping to the speed limit of 70kmh, especially when travelling in a zone monitored by an ASC.
