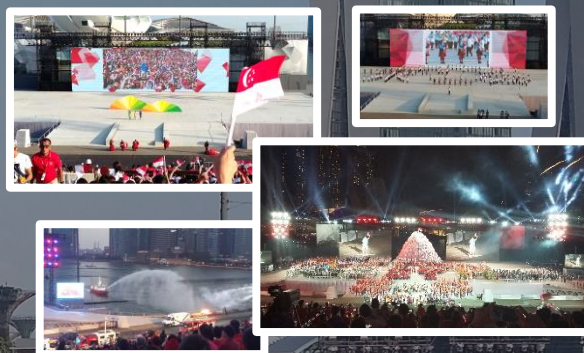

Aviation Open House 2017

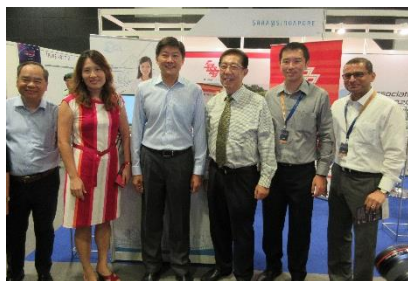

Held once every two years by the Civil Aviation Authority of Singapore (CAAS), the Open House brought the aviation community together to showcase the wide range of career and education opportunities that the aviation industry holds.

The Aviation Open House was launched by Mr Ng Chee Meng, Minister for Education (Schools) and Second Minister for Transport and Mr Kevin Shum, director-general of the Civil Aviation Authority of Singapore at Suntec. In his message shared with the audience, Mr Ng mentioned that with the introduction of new technology such as mobile devices, robotic equipment and autonomous vehicles, among other things, they promise better paying jobs and less physically taxing roles for aviation workers in the future.

CAAS had also signed a memorandum of understanding with the Singapore Scout Association to provide scouts with exposure to aviation, through activities such as flight experiences and aeromodelling.

SAAA@Singapore had contributed its support to this meaningful event through a booth set-up in an outreach to the public. Ms Pauline Tok, SAAA@Singapore Executive Director, had also conducted talks to enlighten audience on the endless possibilities which exist in the aviation industry, be it the job opportunities or the career progression.

The Aviation Challenge

The Aviation Challenge was launched in 2014 with the objective of developing innovative solutions to automate labor-intensive processes in airport operations.

For the first Aviation Challenge, five teams, chosen from the fourteen teams which applied, were awarded a total of S\$9.2 million in funding to develop prototypes from September 2015 to July 2017, to reduce the physical strain of baggage handling workers. The prototypes were then evaluated jointly by a panel comprising senior representatives from the aviation community. On 17th August 2017, ST Dynamics, in collaboration with Israel Aerospace Industries Ltd (IAI), emerged as winner with the winning prototype that will help ease the load of baggage handling workers and was presented a cash prize of half a million dollars.

The second Aviation Challenge will look at how we can automate the process of consolidating cargo into larger pallets and containers for transport in aircraft and the reverse process of taking apart cargo from these pallets and containers. The second challenge is expected to be completed by the end of 2017.

The LEAD Forum 2017 was held on Monday, July 24 at the Grand Copthorne Waterfront Hotel. At this year’s edition of the LEAD Forum, it had been announced that more than 8,300 local small- and medium-size enterprises (SMEs) are expected to benefit from the Local Enterprise and Association Development (LEAD) programme, as the number of projects under it more than doubled last year. Under the programme, trade associations and chambers (TACs) can receive support for industry development projects in areas such as technology and infrastructure, advisory and consultancy as well as research.

There is also the formation of a Logistics Alliance comprising of four TACs, namely SAAA@Singapore, the Container Depot and Logistics Association (Singapore), Singapore Logistics Association and Singapore Transport Association, together with SPRING Singapore and Republic Polytechnic's Centre of Innovation for Supply Chain Management. The memorandum of understanding was inked at the event to mark this formation. Logistics Alliance will develop and drive projects in areas such as innovation, productivity and human capital.

XXI World Congress on Safety and Health at Work 2017

On 3 September 2017, the official opening of the 21st World Congress on Safety and Health at Work was jointly launched by Prime Minister Lee Hsien Loong, International Labour Organisation (ILO) director-general Guy Ryder and International Social Security Association (ISSA) president Joachim Breuer.

Singapore aims to reduce workplace fatalities to less than one death per 100,000 workers in 10 years' time. This can be achieved through the three-way partnership between Government, employers and unions; as well as by encouraging companies to use technology to improve safety.

Some of the key highlights are the \$2 million government fund set up to cover research into solutions that address main causes of fatal traffic accidents at work such as vehicle blind spots and driver fatigue. The new set up of Total Workplace Safety and Health Service Centre in Woodlands will also reach out to small firms which lack resources to roll out workplace safety programmes.

Drug Smugglers turning to Postal Service and Courier Service to bring in Drugs and Drug Paraphernalia

Drug smugglers are getting more creative when purchasing drug and drug taking paraphernalia. Many are resorting to the advances in internet technology and connectivity to make online purchases conveniently.

Central Narcotic Bureau (CNB) has seen an increase in the number of cases where drugs, and drug taking paraphernalia were ordered through the internet and delivered by post, and is aware that there are some online platforms purportedly selling drugs. More than 100 people had been arrested in the first half of 2016 as a result of drugs and drug taking paraphernalia detected in mail and parcels, as compared to 30 in 2015. For those with the misconception that they can evade detection when they sell or purchase drugs through the internet, they cannot be more wrong.

CNB will not hesitate to take the necessary enforcement action against any person found to be involved in such illegal activities. CNB works closely with ICA and the major postal/courier companies to monitor and detect drugs and drug paraphernalia smuggled by post. We will continue to step up our enforcement efforts to prevent the inflow of drugs into Singapore.

2 S'poreans arrested under ISA for terror-related acts

The New Paper had reported on 8th Sept 2017 that a 34 year old managing director of a logistics company was one of two radicalised Singaporeans arrested in July under the Internal Security Act for terror related activities.

Extremist views alarmed those close to him, who reported him to the authorities. Luckily for this gallant act to report on insider threat, potential damage to human lives were averted.

On 19 September 2017, SAAA@Singapore SGSecure Briefing & Workplace Resilience saw managers, gathering at Singapore Aviation Academy Auditorium, to hear from Singapore Police Force (SPF), Ministry of Manpower (MOM) and Central Narcotics Bureau of Singapore (CNB) on SGSecure, Workplace Resilience and CNB controlled substances.

Mr Ken Chua, SAAA Council Member, delivered the opening remarks and mentioned on the purpose of the seminar was to enforce the importance of emergency preparedness for the Airfreight Industry, particularly since there's a high possibility of the Airport being targeted or even the Changi Airfreight Centre. He emphasized on the need for training employees, partnering community and stakeholders, preparing workforce protecting workplace in safeguarding company assets against terrorism threats and ensure workplace functionality in emergencies. He also stated on the need for freight forwarders to be aware of the regulations involved and to be on a vigilant lookout for any parcels or parties which are suspicious and to report it to the relevant authorities.

Mr Billy Lee, Officer-in-Charge, Precursor Control Unit, presented on the precursor control, legislations involving the misuse of Drugs Act while Mr Sam Choo, Team Leader, Changi Airport Team shared on the order of drugs in e-commerce and how to identify tell-tale signs of suspicious parcels.

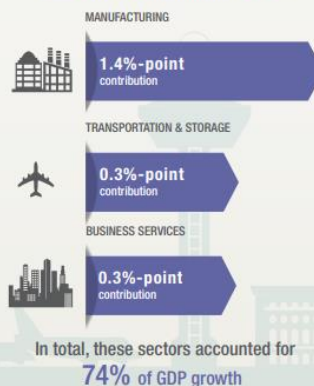

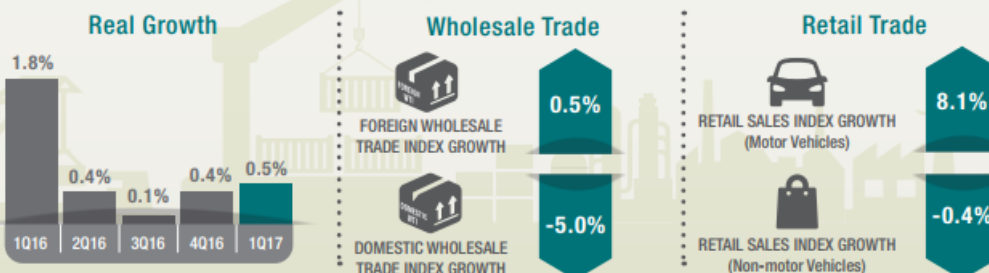

Main Drivers of Growth in 1Q17

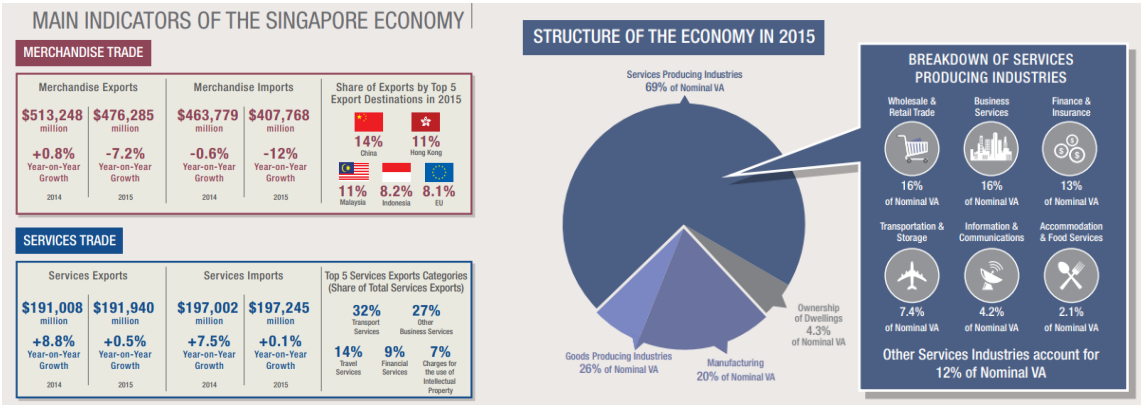

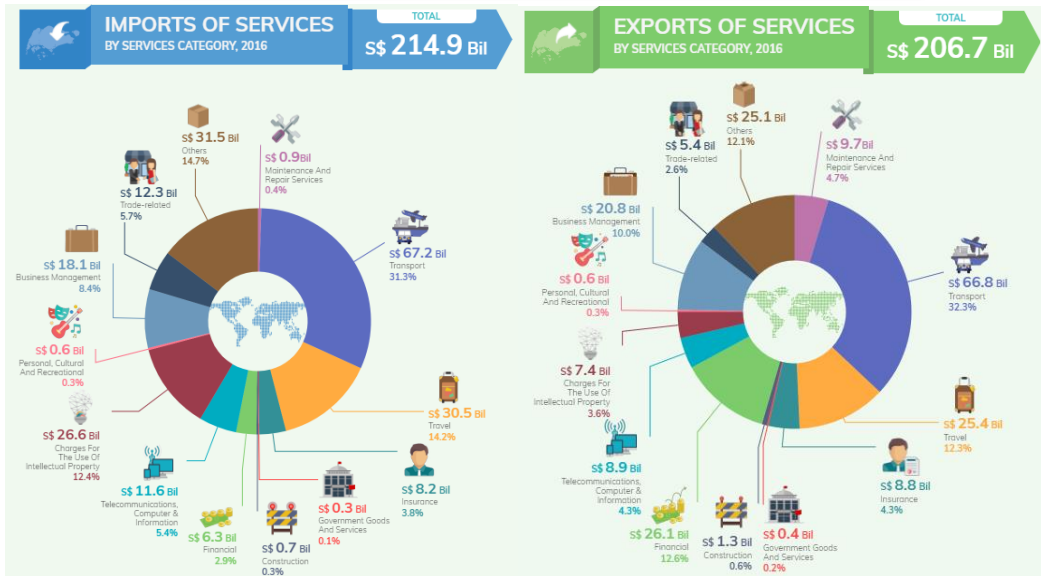

Economical Perspective 2015



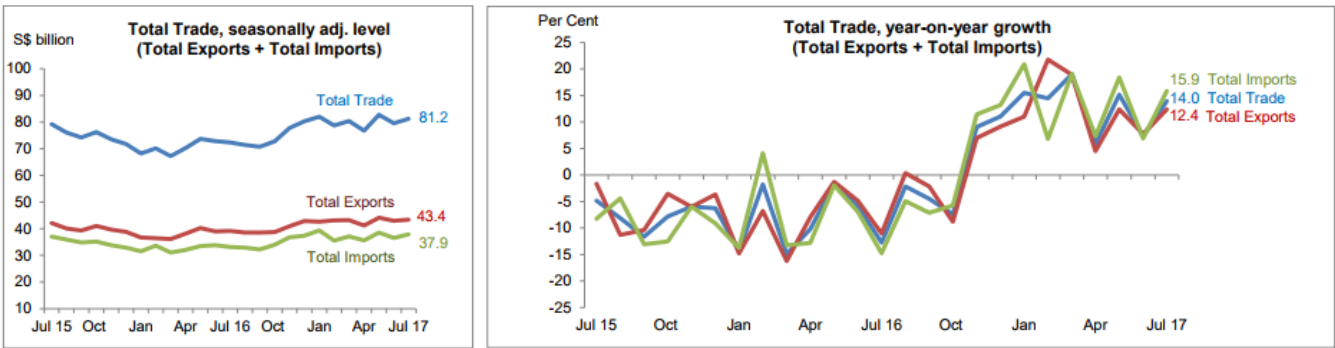

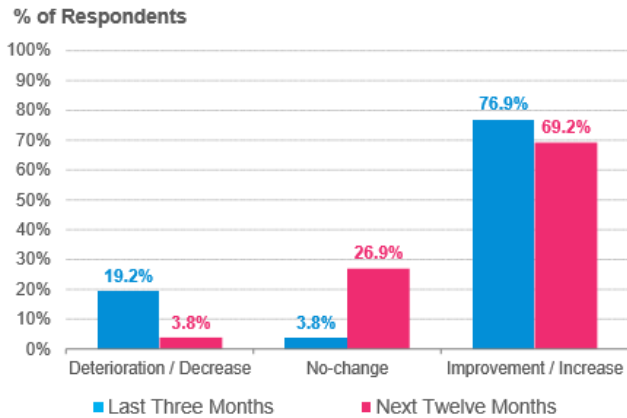

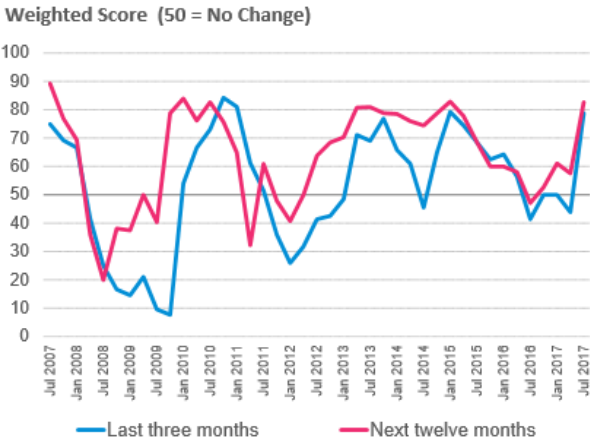

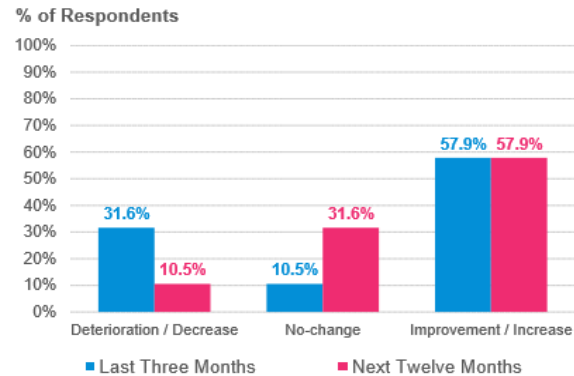

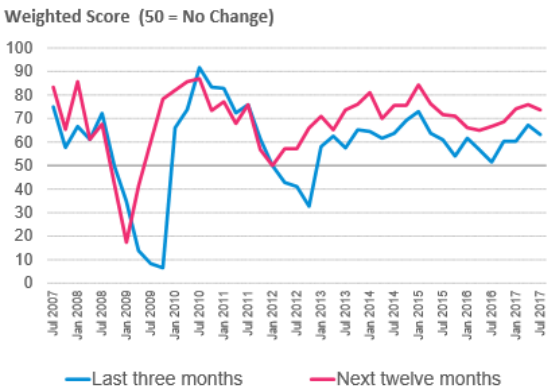

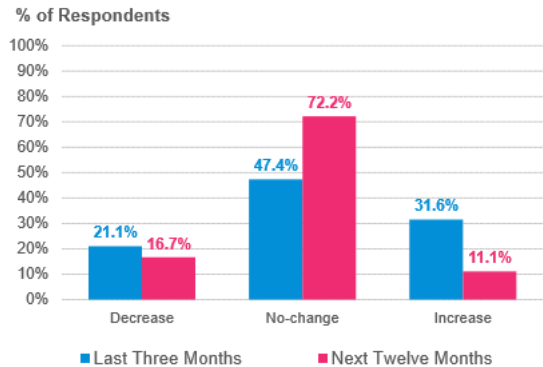

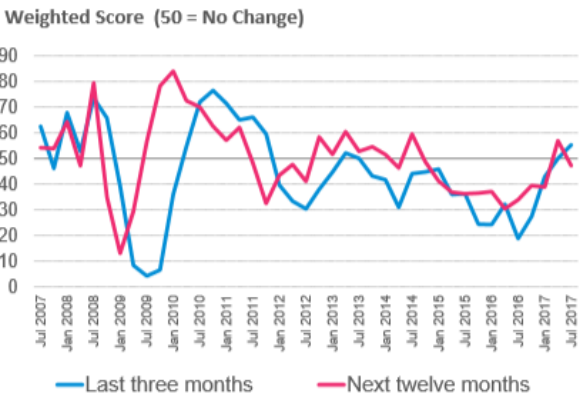

Singapore's National Trade Platform wins International Award for best e-Business Digital Initiative

The National Trade Platform (NTP) project led by Singapore Customs and Government Technology Agency (Govtech) has emerged the winner in the E-business category of the World Summit on the Information Society (WSIS) Prizes 2017.

This is the first time that a digital initiative from Singapore has won in any of the 18 categories of the WSIS Prizes since the inception of these prizes in 2012. The NTP beat other projects from UNCTAD, Mexico, Pakistan and Saudi Arabia to come up tops in the e-business category.

WSIS prizes recognize outstanding digital projects worldwide which foster socio-economic development across categories such as e-government, e-environment, e-science and media. The winners of the 18 categories were announced on 13 Jun 2017 at WSIS Forum held in Geneva, Switzerland.

Pastries include the Curry Puff, Chicken Pie, Tuna Puff, Curry Potato Puff, Apple Strudel, and Chicken Sausage Puff. The vending machine accept Cash, Card (Master card, Visa card, NETS), Ez-Link, Apple Pay and Samsung Pay.

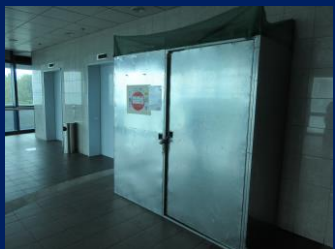
Lifts Upgrading in Cargo Agents Building D & E

CAB D and CAB E lifts were last installed in 1992 and 1997 respectively.

The new lifts, which are now motor roomless, are equipped with modern technology like VVVF (Variable Voltage Variable Frequency) and sleep mode features. Currently, these features are commonly installed in most new buildings for better energy efficiency and in compliance with the BCA's Green Mark requirements for Lift System.

The upgraded lifts are in compliance with BCA Accessibility Code for handicapped people. There are braille buttons (for visually handicapped), lower call buttons and new hand rails. In addition, the sensors at the doors help to improve safety of users and enhance the reliability of the lift operations. Chequered plates and bumpers have been installed at the sides to prevent damages to the lift interior. Lastly, the new lifts are also installed with energy efficient LED lights and new speakers.

The whole replacement works for lifts are targeted to be completed by 4th quarter of 2017. Do look forward to new lifts making the rides more smooth and consistent than before and enhance safety and reliability by reducing downtime.
